

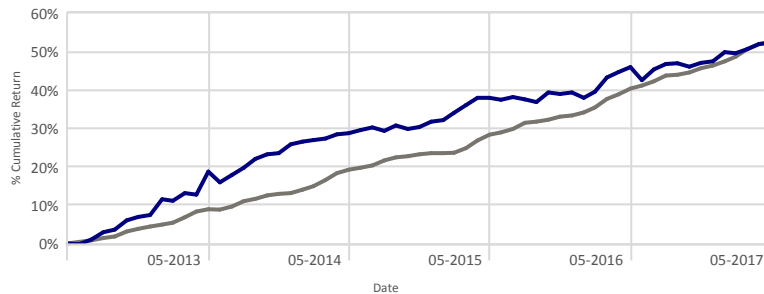
INVESTMENT OBJECTIVE

The NeFG BCI Income Provider Fund is a cautious managed portfolio with the objective to provide investors with a high level of income combined with stable medium to long term real capital growth.

INVESTMENT UNIVERSE

The investable universe of the portfolio includes interest bearing securities (including, but not limited to bonds, convertible bonds, debentures, corporate debt, cash deposits and money market instruments) as well preference shares, equity securities, property securities, convertible equities, derivatives and non-equity securities and assets in liquid form. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act, and the Regulations thereto, as amended from time to time, in order to achieve the portfolio's investment objective. This fund complies with Regulation 28.

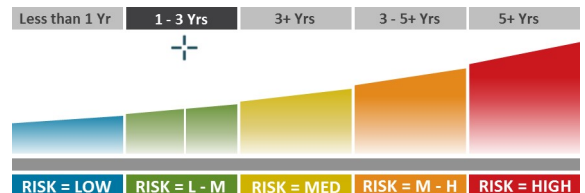

Low - Medium Risk
